



## Terms & Conditions

*Veteran Owned & Operated Mobile Golf Simulator*

### 1. General Terms

These Terms & Conditions govern all rentals and services provided by Fore the ParTee, LLC ('Company'). By booking an event, the Client agrees to comply with all policies, procedures, and requirements outlined in this document.

### 2. Rental Hours

Rental time begins at the scheduled event start time and concludes at the scheduled end time listed on the Rental Agreement. Setup and teardown are not included unless otherwise agreed. Additional rental time is subject to availability and additional fees.

### 3. Setup Requirements

Client shall provide a level setup area, adequate space, safe access, and electrical power if available. A generator may be provided as an optional add-on.

### 4. Approved Equipment Use

Only equipment provided or approved by Fore the ParTee may be used, including approved golf balls, clubs, and simulator accessories.

## **5. Prohibited Conduct**

No climbing on the enclosure, hanging on screens, throwing clubs, reckless behavior, tampering with electronics, or using unapproved golf balls. Violations may result in termination without refund.

## **6. Children**

Children under 16 must be supervised by a responsible adult at all times.

## **7. Alcohol**

Alcohol is permitted only where lawful. Unsafe or impaired participants may be removed.

## **8. Food & Drinks**

Food and beverages must be kept away from the projector, launch monitor, iPad, television, cables, and other electronics.

## **9. Weather**

Outdoor events may be suspended for lightning, severe winds, heavy rain, or unsafe conditions. Rescheduling will be attempted when practical.

## 10. Equipment Damage

The Client is financially responsible for damage caused by negligence, misuse, intentional acts, failure to supervise minors, or failure to follow instructions. This includes all simulator equipment. Normal wear is expected.

## 11. Cancellations & No-Show Policy

Deposits are fully refundable with at least 24 hours written notice. Later cancellations or no-shows forfeit the deposit. Client delays do not extend rental time. Severe weather rescheduling/refunds are at Fore the ParTee's discretion.

## 12. Right to Refuse Service

Fore the ParTee may terminate events without refund for unsafe conduct, threats, illegal activity, equipment damage, or failure to follow safety instructions.

## 13. Photography & Media Release

Unless the Client opts out in writing before the event, photographs or videos may be used for promotional purposes.

## 14. Governing Law

These Terms are governed by Florida law. Invalid provisions do not affect the remainder of the agreement.
